**Rules:** The regatta will be governed by the Racing Rules of Sailing 2021-2024 (RRS), as modified by Appendix E regarding radio sailing, the Sailing Instructions, and class rules (if any). Measurement of all boats will be conducted at Check-in.

**Eligibility:** The regatta is open to skippers who are current members of the AMYA (or their national authority), where the boats are properly registered and have met regatta measurements.

**Registration:** Advance Registration before November 5, 2021, is required. AMYA registration status will be checked in advance of the regatta. Registration form is attached to this NOR.

**Covid 19:** The regatta will be sailed under COVID 19 protocols in effect for the state of Florida and County of Charlotte as of November 1, 2021. Sun Coast Model Sailing Club reserves the right to ask non-vaccinated attendees to wear a face mask and to keep a safe distance.
